WE TAKE A PREVENTATIVE, EARLY INTERVENTION APPROACH THAT BREAKS THE CYCLE OF POVERTY AND ABUSE BY HELPING CHILDREN IN NEED TO OVERCOME THE MANY OBSTACLES IN THEIR LIVES.

THE CHILDREN IN THE PROGRAM HAVE SIGNIFICANT CHALLENGES WITH 60% HAVING PARENTS THAT DID NOT COMPLETE HIGH SCHOOL, 50% HAVING ONE OR MORE PARENT THAT HAS BEEN INCARCERATED, AND 85% BEING BORN BY A TEEN PARENT.
